Candidates appeared for LL.M Common Entrance Exam-2022 conducted by the Department of Law, University and have passed LL.B (3 years Course) or B.L.S/LL.B (5 years course) from the University of Mumbai or other recognized Universities are also eligible to apply for LL.M Admission 2022-23.

Cancellation Policy :

The Candidate shall apply through email or offline for cancellation and submit duly signed copy of system email application for cancellation of admission to the Institute.
