1) Environmental Policy:

This comprehensive framework addresses environmental issues holistically, drawing insights from nearly every academic discipline.

The three core principles of this policy are:

- Rejection of the "Business as Usual" model.
- A strong commitment to environmentally sustainable development.
- A dedication to fostering an environmentally just legal system.

In the B.L.S./LL.B, LL.B & LLM. programs, Environmental Law and Policy is a mandatory core course. It serves as a natural progression from the Natural Resource Management Course (Land Laws) and employs a transdisciplinary approach to offer students an in-depth understanding of environmental governance. This course builds upon principles of resource management and introduces key norms governing environmental policies. While primarily focusing on Indian laws and policies, the course also incorporates global influences and practices to provide broader context.


Set against the backdrop of the environmental crisis and India's global environmental evaluation, the course begins by exploring fundamental theories of environmental management. It also covers significant topics such as eco-sensitive zones, coastal area management, and environmental justice implementation. By blending theoretical concepts with practical applications, the course prepares students for specialized legal practice in this area. Topics such as climate law and litigation further enhance the course's practical focus.

The course is conducted offline, employing teaching tools such as PowerPoint presentations and short video clips to facilitate discussions on various pre-selected topics. Each lecture concludes with interactive discussions, and students are often assigned projects to encourage deeper engagement and strategic thinking. The objective is to equip students with both the theoretical foundation and practical expertise necessary to apply environmental law effectively in real-world scenarios.

2) Restricted entry of automobiles.

The college limits vehicle entry to minimize carbon footprints on campus, allowing only the Management and Principal, Dr. Mrityunjai Pandey, to park their vehicles. However, on occasion, guests are permitted to park within the campus with the Principal's approval.
