Assistive Technology and Facilities

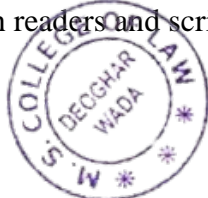
Recognizing the importance of technology in bridging accessibility gaps, the college provides assistive tools to support Divyangjan students in their academic pursuits. These include:


- A fully accessible college website compatible with screen-reading software for visually impaired users.

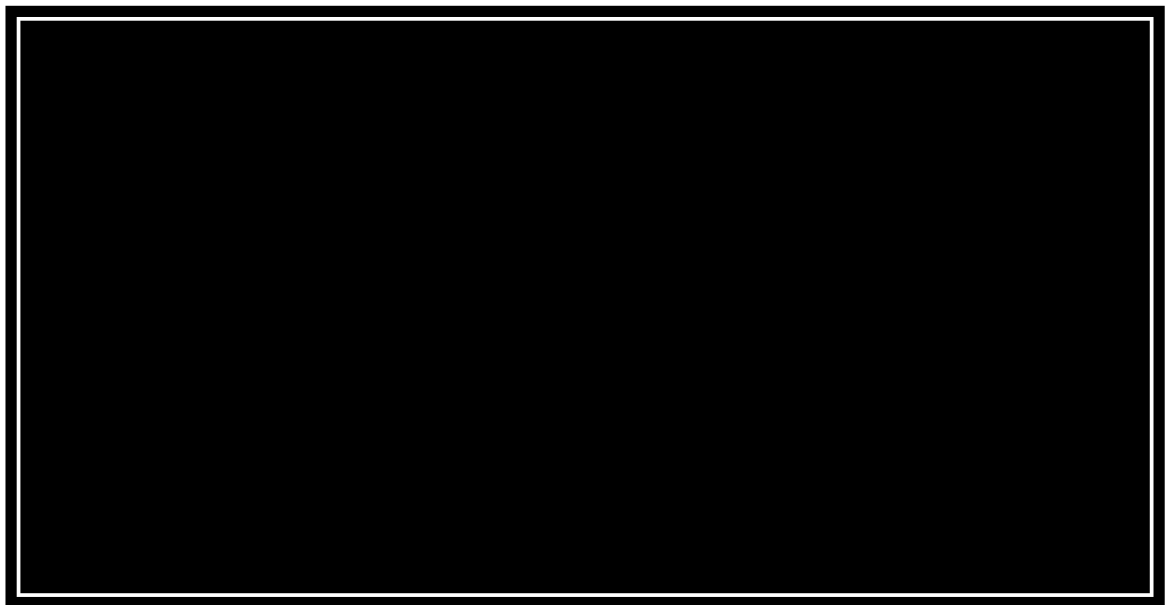
