4.1.1 The institution has adequate facilities for teaching-learning viz., classrooms, laboratories, computing equipment, etc.

Infrastructural facilities used for teaching-learning purposes include:

M S College of Law Wada is center for imparting professional education. It has 3540 sq.mt. built up area for conducting its curricular, co- curricular as well as extra –curricular activities. M S College of Law Wada functions within two floors of the said building. It has one entrances. On the ground floor there is Principal 's office, Administrative Office, Debate Room, Seminar Hall, Library & e-Library, reading room for the students, NAAC/IQAC Office, Moot court Hall, Ladies common room with Ladies toilet, Computer Lab/E-Library, Toilet for physically handicapped people, Legal Aid Cell for people of North Eastern States, Competitive Examination Cell and lift facilities are also available.

Classrooms: 20 classrooms are available for the students. All the classrooms are utilized for teaching purpose. Each class room is well equipped white board, and benches with seating capacity of 60 students. 10 class rooms are well equipped with LCD Projector.

Library: A library is well maintained with Text books, Reference books, National and International reputed Journals, Articles, Magazines, Novels, Newspapers, Updated software Delnet, Total available Book are 5271.


Reading Room: A separate reading room facility is available for Students.

Seminar Hall: A seminar hall is available with 120 seating capacity, equipped with LCD projector, sound system, a white board and adequate number of Ceiling Fans. Seminar Hall is used as an auditorium for the institute. It can accommodate 120 students can sit in the hall at a time. The Institute uses the auditorium for guest lectures, various programmers etc.

Video Production Studio: It is a futuristic studio set up to provide hands-on learning experience in video production, facilitate news bulletins, interviews, and discussions for television programs by students of the Department of Journalism and Mass Communication. 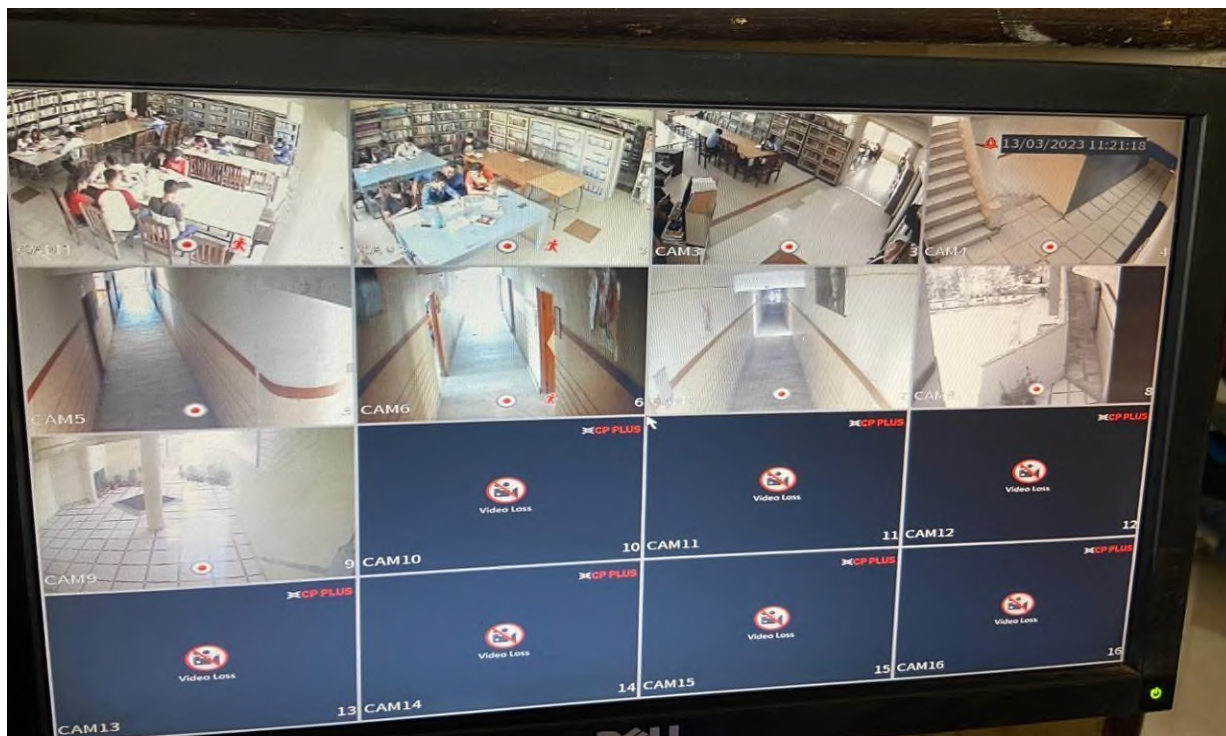

Hostel
